We may request a deposit to cover all third party payments made on behalf of clients – this will be payable at least 3 days before the day of the funeral. A final, itemised, invoice will be sent to clients after the funeral has taken place.

### **Payment Terms**

Full payment should be made within 30 days of the date of the final invoice. If there are extenuating circumstances this may be extended by agreement. If no prior agreement has been reached any payments made after this date will incur interest charges of 10%
